Camp Check-In: Campers may begin arriving at camp **after 6pm on Friday**, not before.


Camp Departures: Campers should plan on departing from Camp by 11 am on Sunday.

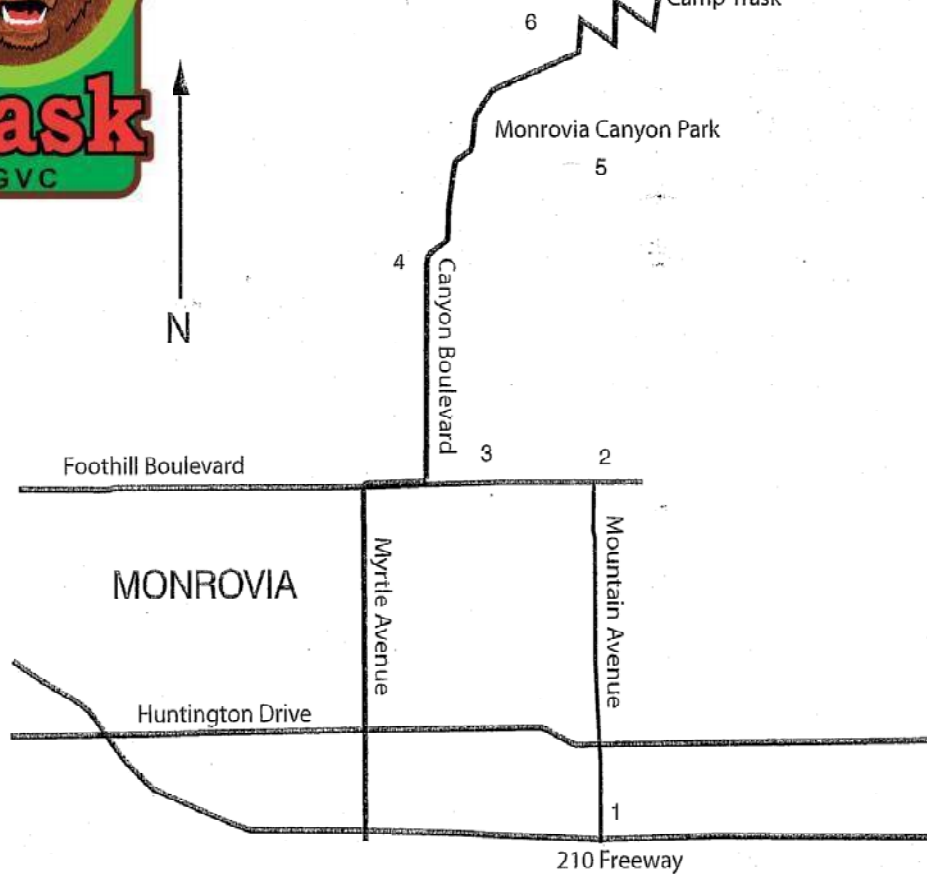

Directions to Trask Scout Reservation

Take the 210 Freeway to the Mountain Avenue offramp, in Monrovia. Exit at Mountain, and turn north towards the mountains. Follow Mountain up to Foothill Blvd. Turn left on Foothill and follow it to Canyon Blvd. Turn right on Canyon Blvd. Follow Canyon Blvd. up the hill. After crossing Hillcrest Blvd., which has a stop sign, Canyon will fork. Stay on the right fork. There will be signs indicating Trask Scout Reservation and Monrovia Canyon Park. There is a combination lock at the entrance and a second combination lock at the Bridge. The combinations are changed weekly. Please note the combinations above. They are for the week/weekend that you are attending. One more thing – the road into camp is paved and has some tight turns.
